Terms and Conditions:

All requested information is required. Upon approval, we will automatically bill your credit card for the amount indicated. Your charges will appear on your monthly credit card statement. To cancel this automatic billing authorization, you must do so in writing via info@gobair.org or by letter sent to the address above. Written cancellation must include name, address, phone number, card card number, effective date of cancellation, and the BIAC program in which you participated. Such cancellations will take effect no sooner than 30 days after receipt by BIAC. Minimum charges apply depending on the class of membership for which you have applied. BIAC reserves the right to reinstate billing if the member is found to be using the BIAC facilities after the effective date of requesting cancellation, including billing for the period between the effective date of requesting cancellation and the date when the member is found to be using BIAC facilities.

This form represents a contract between the cardholder and the Bair Island Aquatic Center; signing it binds the cardholder to the minimum payments indicated above. All billing disputes that cannot be settled between the cardholder and BIAC shall be settled according to the dispute resolution process specified by the card issuer in the credit card agreement to which the cardholder is a party.
